No items shall be sold or withdrawn from the auction prior to the auction except by mutual agreement between the Seller and Auctioneer. No contracted item shall be altered, have any part removed or changed in any way, unless agreed upon by the auctioneer, with a signed amendment stating what changes and/or alterations have been made.

Seller agrees to hold harmless the Auctioneers against any claim referred to this contract.

All terms of this contract shall remain private and confidential by both Seller and the Auctioneer.
